In the event of a second or subsequent noncompliance of the same rule within one year after this Warning Notice of Violation, the Landlord may either terminate Tenant's tenancy pursuant to ORS 90.392 or assess a noncompliance fee. The noncompliance fee shall be: \$ _____ (\$250.00 if left blank, if second or subsequent violation of keeping on the premises an unauthorized pet capable of causing damage to persons or property or smoking in a clearly designated nonsmoking unit or area of the premises and may not exceed \$250.00). For all other violations \$ _____ (\$50.00 if left blank, if second or subsequent violation and may not exceed \$50.00) or \$ _____ (\$50.00 if left blank, plus 5% of the rent if third or subsequent violation and may not exceed \$50.00).

WARNING NOTICE: The defaults or conduct set forth in this notice constitute a violation of your Rental Agreement. If your tenancy is a fixed-term tenancy, your Landlord may choose to terminate the tenancy at the end of the fixed term if there are three violations of your Rental Agreement within the twelve (12) month period preceding the end of the fixed term. Correcting the third or subsequent violation is not a defense to such a termination.
