- 3) Tenant(s) are responsible for conduct of pet(s) at all times and are responsible to clean up after pet(s). Tenant(s) shall promptly pick up all pet droppings as they occur.
- 4) Tenant(s) shall be liable for any damages caused by the pet(s) and any additional security deposit shall be applied to any such damages.
- 5) Pet(s) shall not cause any sort of nuisance or disturbance to the neighbors. Tenant(s) shall immediately report any damage by pet to people or property. Tenant(s) represents and warrants that the pet(s) have not damaged people or property.
- 6) This agreement is incorporated into and shall become part of the Rental Agreement executed between the parties.
- 7) Tenant(s) shall pay the deposit required for keeping a pet as outlined in the rental agreement. No deposit shall be required for an assistance animal for a disabled tenant.
